On July 8, 2024, notice (the “**Conditional Notice of Redemption**”) was given by Rossini S.à r.l. (the “**Issuer**”) in accordance with Sections 3.03, 3.04 and 3.07 of the indenture dated as of October 26, 2018, as amended and supplemented from time to time (the “**Indenture**”), by and among, *inter alios*, Rossini S.à r.l. (the “**Issuer**”), Deutsche Trustee Company Limited as trustee (the “**Trustee**”), Deutsche Bank AG, London Branch, as security agent (the “**Security Agent**”), paying agent and calculation agent and Deutsche Bank Luxembourg S.A. as Transfer Agent and Registrar, pursuant to which the Issuer issued its €650,000,000 Senior Secured Fixed Rate Notes due 2025 (the “**Fixed Rate Notes**”) and its €650,000,000 Senior Secured Floating Rate Notes due 2025 (the “**Floating Rate Notes**” and, together with the Fixed Rate Notes, the “**Notes**”).

The terms not otherwise defined herein shall have the same meanings given to them in the Conditional Notice of Redemption.

The Refinancing Condition will be satisfied on July 18, 2024 and the Issuer will therefore redeem the entire principal amount of the Notes outstanding, in accordance with the terms set out in the Conditional Notice of Redemption on July 18, 2024, which shall be the “Optional Redemption Date” for the purposes of the Conditional Notice of Redemption.
